This consignment agreement is between Blue Cat Vintage (retailer), and the consignor. This agreement is applicable to all items listed in the inventory portion of this agreement or on a separate spread sheet.

- 1) All items will be consigned for a term of no less than 90 days (this term can be reduced at the retailer's discretion).
- 2) If we pick up your items, a minimum pickup fee of \$75.00 will be charged for each pickup trip. This fee may vary depending on distance traveled and size/weight of items. The pickup fee will be deducted from the consignor's proceeds of sale.
- 3) We, the retailer, will determine the initial price for each item.
- 4) At retailer's discretion, consignor's items will be housed at either of the retailer's physical locations.
- 5) Payment:
 - a. Consignor will receive 50% of the price that each item sells for, after deducting for expenses. i.e. light bulbs, pickup fees, etc
 - b. Retailer will email a reconciliation of items sold and price attainment within 10 days of the close of business for each month.
 - If none of the consigned items sell during the month, there will be no report sent.
 - c. Payment to the consignor will be mailed around the 15th of the month, following the date of sale.
 - d. Post Office delays are becoming prevalent, so the exact delivery date for your payment depends on the Post Office.

- e. The check will be made payable only to the person on this agreement.
 - f. If you pick up the check, it will be released only to the person listed on this agreement.
 - g. If the amount owed to the consignor is less than \$3.00, the payment may be held over to the following month.
 - h. Checks will be mailed via the US Bank “Bill Pay” system and the bank account name is **Bucket List, LLC**.
- 6) Consignor authorizes retailer the right to negotiate the final sales price.
 - 7) At retailer’s discretion, retailer may market and sell some or all the consigned items using an online service. i.e. eBay, Etsy, or some other service.
 - a. Online services charge a fee for their service.
 - b. Shipping costs will also be assessed.
 - c. The specific sales and shipping fees will be subtracted from the sales price of the item or items and then the remainder will be split 50/50 with the consignor.
 - 8) At the end of the first 30 days, the retailer may reduce the asking price by 20% of the original price.
 - 9) At the end of the second 30 days, the retailer may reduce the asking price by 50% of the original price.
 - 10) After 90 days, the retailer will continue to reduce the price until the items are sold, donated, or picked up by the consignor.
 - 11) This agreement has no definite expiration date. (this term can be altered at the retailer’s discretion).
 - 12) Within 7 days following the retailer’s notice to consignor to remove any or all the consigned items, consignor is to remove all unsold items.
 - a. Notice may be by email, text, verbal, phone, or written notice.
 - b. After the 7-day pickup window, the remaining items will become the property of Blue Cat Vintage.
 - 13) **Any item that requires light bulbs or batteries is to be consigned with said items. All light bulbs are to be LED bulbs. If not LED, Blue Cat Vintage will provide or replace these items and deduct this expense from the consignor’s revenue.** _____Initial
 - 14) **At the end of the 7 days following retailer’s notice to consignor to remove any or all items, retailer will assume ownership of the unsold items without notice and without liability.** _____Initial
 - 15) **Blue Cat Vintage cannot force guests, Purveyors, and employees to pay for accidental damage to merchandise.** _____Initial
 - 16) **Blue Cat Vintage is not responsible for any loss due to theft, accident, negligence of any person, or other occurrences.** _____Initial

17) **Consignor understands that Blue Cat Vintage has no insurance that will protect consignor's items.** _____ Initial

18) **If we pick up your items, a minimum pickup fee of \$75.00 will be charged for each pickup trip. This fee may vary depending on distance traveled and size/weight of items. The pickup fee will be deducted from your proceeds of sale.** _____ Initial
